

FLOAT ROOM LIABILITY WAIVER & PROFESSIONAL AGREEMENT

We want you to have an amazing and safe experience with us at Ohm Lifestyle Center and request that you be aware of and agree to the following information and policies:

Facilities: Amenities provided include: Towels, Washcloth, Ear plugs, Shower Flops, Halo Head Pillow, Vaseline, Cotton Swabs, Shampoo/Body Wash, and Shower. Caution is up to you to prevent slipping or falling as surfaces may be wet. The facility is filtered, cleaned and sanitized between each session.

Fees: Float sessions are 60 minutes. Fees vary based on the desired service package. These fees are subject to change. We require payment for services at the time of service.

Cancellation Policy: You must cancel scheduled sessions 24 business hours in advance; otherwise, you will be charged 100% of the normal session fee, even if the cancellation was unavoidable.

I agree to **NOT** use the Float Cabin if:

- I have not showered thoroughly and still have oils, creams, or makeup on my body.
- I have had any type of hair color/treatment within the past 2 weeks.
- I have had a spray tan or used self-tanning products within the past 2 weeks.
- I am under the influence of alcohol or drugs.
- I have a communicable or infectious skin condition, disorder, or diseases; or open sores.
- I am diabetic, unless my diabetes is under medical control.
- I have a history of heart trouble, epilepsy, seizures or blackouts and have not received my doctor's permission to use the floatation tank.

- I am experiencing an external vaginal/penile episode, or if I am having a heavy menstrual cycle.
- I have a condition which may be adversely affected by cutaneous absorption of magnesium.
- I have kidney disease.
- I have incontinence, or voluntarily/involuntarily release of bodily fluids of any kind.

INITIAL	<ol style="list-style-type: none">1) I understand that I am required to shower without using products before my float.2) The float tank solution is not discarded between floats, but is filtered, sanitized and recycled; that our tanks are inspected between every single float; and that violation of any of these rules that results in contamination of the float tank solution may result in a cleaning, damage or salt replacement fee of \$500-1500+ depending on the damage.3) I am not currently menstruating, and if I am light/moderate that I will use insertable types of feminine hygiene products (tampon, cup, etc.)
